## Recap of the March 27 Annual Homeowners Meeting

However, more than 70 mail-in ballots were received, allowing the current year budget and vote for board membership to pass. Since a quorum was not present, no other business was completed. However, it was good meeting with a lot of positive discussion. Thanks to everyone who came and also to the homeowners who submitted their ballots by email prior to the meeting.

- A few of the ideas that were discussed.
  - **Front entrances**. The Wingate Garden Club is being asked to take a more active role in plant selection for the entrances. We will continue to pay a service to maintain the entrances.

## Wingate Trail System

Wingate was designed as horse-acreage after the model of Bridle Trails in Bellevue. And early on, many families kept horses and rode them on the trails (and in the 4<sup>th</sup> of July parade). The trail system is a big part of that model and is still well used and enjoyed by many in the neighborhood.

Each trail is built on easements from adjacent homeowner properties. If your home abuts one of the trails, you are a part-owner and responsible for maintaining it.

#### Some general thoughts for trail owners:

- Keep the trail clear and passable. Fences or structures that block the trail are not allowed (nor are they neighborly).
- If you need help with your trail section, contact the <u>board</u> for support. Some potential issues are overgrown brambles, downed trees and boggy areas.

Trail users can help keep the trails clean and usable by picking up litter and by reporting any maintenance issues to the adjacent homeowners or the board. If you want to get more involved with trail maintenance, be sure to first coordinate with the adjacent homeowners.
