**Ending Balance** 

- a. 2013 dues income includes 104 payments of \$50, four of which are advance payments for 2014 dues.
- b. 2014 budget to be voted on in conjunction with the Wingate HOA annual meeting on April 2, 2014.
- c. 2014 income assumes 130 of our 202 Wingate homeowners pay their \$50 annual dues. Please do your part!
- d. 2013 expenses are much lower than 2013 budget due to the use of surplus supplies that were purchased in 2012, along with some supplies donated by Wingate HOA members.

- e. 2014 budget includes expenses for fall social banners purchased in 2013 and to be paid in 2014. Replacement of our old entrance signs/banners are scheduled for 2013 & 2014 and are not an ongoing expense.
- f. Web hosting/web domain expenses of about \$50/year are currently being donated by a Wingate HOA member.
